II. CHARGES AND SPECIFICATIONS

CHARGE I: Violation of UCMJ, Article 90

Specification: In that CAPTAIN JACOB R. WULFSON, United States Air Force, having received a lawful command from [REDACTED] his superior commissioned officers, then known by the said Captain Jacob R. Wulfson to be his superior commissioned officers, to not contact or communicate with [REDACTED] directly or through a third party, and to remain at least 300 feet away from [REDACTED] and her household, or words to that effect, did, within the [REDACTED], between on or about 4 December 2023 and on or about 28 February 2024, willfully disobey the same.

CHARGE II: Violation of UCMJ, Article 120

Specification 1: In that CAPTAIN JACOB R. WULFSON, United States Air Force, did, at or near [REDACTED], on or about 1 December 2023, commit a sexual act upon [REDACTED], by penetrating her vulva with his penis, without her consent.

Specification 2: In that CAPTAIN JACOB R. WULFSON, United States Air Force, did at or near [REDACTED], on or about 1 December 2023, commit a sexual act upon [REDACTED], by penetrating her vulva with his penis, when she was incapable of consenting to the sexual act because she was impaired by a drug: to wit: etizolam, and the accused knew of that condition.

CHARGE III: Violation of UCMJ, Article 128b

Specification: In that CAPTAIN JACOB R. WULFSON, United States Air Force, did, at or near [REDACTED], on or about 1 December 2023, commit an assault upon [REDACTED], the intimate partner of the accused, by unlawfully strangling her with his hand.
