Pursuant to Secretary of the Air Force designation, as memorialized in the Fiscal Year 2024 Worldwide Convening Authorities Designation Memorandum, dated 12 June 2024, a general court-martial is hereby convened. Additionally, if the accused is a commissioned officer, or if the accused is an enlisted member and submits a request pursuant to Article 25(c)(2)(A), UCMJ, all enlisted members shall be temporarily excused and the court be composed entirely of commissioned officer members.

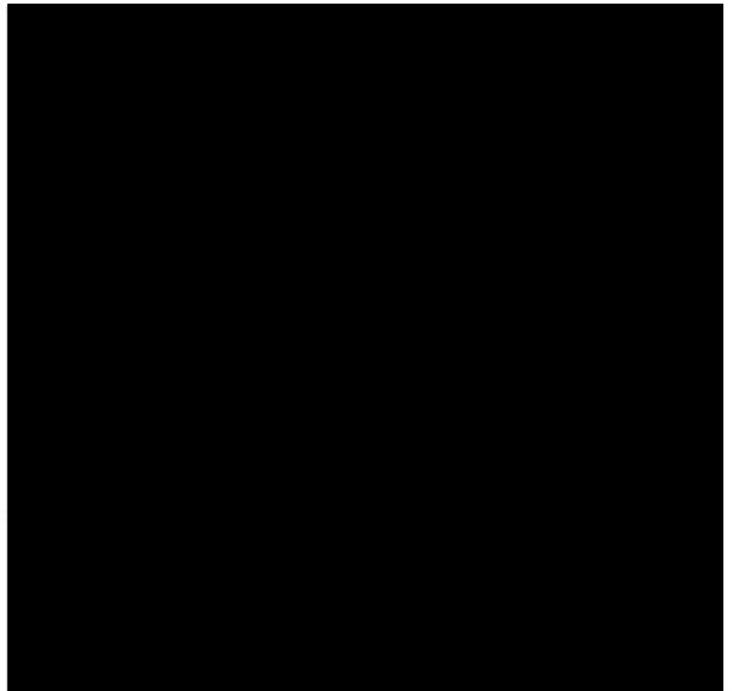
