Pursuant to Secretary of the Air Force designation, as memorialized in the Fiscal Year 2024 Worldwide Convening Authorities Designation Memorandum, dated 12 June 2024, a special court-martial is hereby convened. It may proceed at Luke Air Force Base, Arizona to try such persons as may be properly brought before it. The following members are permanently detailed to this court-martial. All members junior to the accused by rank or grade shall be temporarily excused. Additionally, if the accused is a commissioned officer, or if the accused is an enlisted member and submits a request pursuant to Article 25(c)(2)(A), UCMJ, all enlisted members shall be temporarily excused and the court be composed entirely of commissioned officer members.
