Specification 3: In that MASTER SERGEANT JEFFERY K. ANDERSEN, United States Air Force, 3d Maintenance Squadron, Joint Base Elmendorf-Richardson, Alaska, at or near Joint Base Elmendorf-Richardson, Alaska, on divers occasions between on or about 20 February 2020 and on or about 19 February 2021, did maltreat [REDACTED], a person subject to his orders, by pointing a pocket knife at [REDACTED] while saying, "don't fuck this up" and "I'll cut you," or words to that effect.

CHARGES AND SPECIFICATIONS

CHARGE III: Violation of the UCMJ, Article 92

Specification: In that MASTER SERGEANT JEFFERY K. ANDERSEN, United States Air Force, 3d Maintenance Squadron, Joint Base Elmendorf-Richardson, Alaska, who knew of his duties at or near Joint Base Elmendorf-Richardson, Alaska, on divers occasions between on or about 23 June 2019 and on or about 19 February 2021, was derelict in the performance of those duties in that he willfully failed to maintain professionalism at his workplace by throwing objects, brandishing a rod, hitting surfaces near his subordinates with the rod, yelling at his subordinates in an excessively loud manner, and verbally belittling his subordinates in front of their peers, in violation of paragraphs 2.1 and 2.2.8 of Air Force Instruction 1-1, Air Force Standards, dated 7 August 2012, Incorporating Change 1, dated 12 November 2014, as it was his duty to do.
