SUBJECT: *U.S. v. SrA Logan A. Mcleod*, Mil. R. Evid. 404(b) Notice #1

1. Pursuant to M.R.E. 404(b) and the Military Judge's Scheduling Order, the Government provides notice of the general nature of the following crimes, wrongs, or other acts of SrA Mcleod (the Accused). The Government intends to offer the following in the findings and/or sentencing phases of the trial. To the extent such other acts include statements by the Accused, the prosecution provides notices of those statements under 304(d).

f. The Accused pretended to withdraw from his plan to commit the charged offenses, in order to trick law enforcement into thinking that he did not intend to go through with it. The government offers the above to show the intent, consciousness of guilt and knowledge of the offenses on the part of the Accused.

g. In August of 2021 the Accused stated that he wanted to kidnap a young woman and sell her to sex traffickers, and also stated that he wanted to kidnap and rape the woman's minor sister, because the young woman was ignoring him on social media. Additionally, the Accused went to the woman's residence, to scope it out. The government offers the above to show the intent, and motive on the part of the Accused.

j. While planning the execution of the charged offenses, the Accused requested that his conversations with J.O. be conducted via “burner phones”, and through a secure messaging application in order to avoid detection. Additionally, the Accused made J.O. screen record herself deleting their messages. The government offers the above to show the consciousness of guilt and knowledge of the offenses on the part of the Accused.

k. While planning to commit the charged offenses, the Accused discussed kidnapping and raping various other women and children. The government offers the above to show the motive and intent on the part of the Accused.

m. While selecting a location to commit the offenses, the Accused scoped out specific areas/locations in person and over the internet. The government offers the above to show the intent on the part of the Accused.

n. The Accused discussed his plans to avoid detection while traveling to commit the charged offenses. The Accused told J.O. that he would remove his license plate every time he went to visit the victims. The government offers the above to show the consciousness of guilt and knowledge of the offenses on the part of the Accused.

o. The Accused discussed his plans to kidnap and murder a woman and her sister. The government offers the above to show the motive and intent on the part of the Accused.

p. The Accused suggested that J.O. get another man’s semen, and place it on A.B.’s clothes in order trick law enforcement into thinking that someone else raped her. The

government offers the above to show the consciousness of guilt and knowledge of the offenses on the part of the Accused.

q. The Accused attempted to purchase a minor child, and an adult woman from a sex trafficker. The Accused met with “the trafficker” during duty hours, and paid him in person. During the encounter with “the trafficker” the Accused accepted a blue dinosaur toy, that was meant to serve a signal that everything was ok. When the Accused was apprehended on 18 September 2021, he had the blue dinosaur toy in his pocket. The government offers the above to show the intent and motive on the part of the Accused.

r. The Accused purchased various supplies such as: drugs(to include but not limited to: Xanax, Ecstasy, and MDMA), tape, chains, glue, facemasks, a camera, and a strait jacket, in order to carry out his plans to kidnap, rape and murder. The Accused also paid for an Air BnB to facilitate the commission of the kidnapping, rape, and murder. The Accused also had a dildo in his vehicle when he arrived at the residence on 18 September 2021. The government offers the above to show the motive and intent on the part of the Accused.

t. In accordance with his agreement with “the trafficker” the Accused purchased a facemask, and got a covid test prior to showing up to meet with the VIC’s. The government offers the above to show motive and intent on the part of the Accused.

w. The Accused discussed his ideas, and made plans regarding the disposal of a dead body. The government offers the above to show the motive, intent, and consciousness of guilt on the part of the Accused.

3. Pursuant to *United States v. Hyppolite*, 79 M.J. 161 (CAAF 2019), the government intends to use each specification as proof of the other. The government offers the above to show the motive, intent, common plan or scheme, absence of mistake, and lack of accident on the part of the Accused.

4. The Government understands its continuing disclosure requirement and will supplement this disclosure as needed. To the extent necessary. The Government also provides notice of these statements pursuant to M.R.E. 304(d).
