10. ADDITIONAL CHARGE: Violation of the UCMJ, Article 80

Specification 1: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, between on or about 1 August 2021 and on or about 5 August 2021, attempt to conspire with [REDACTED] to commit an offense under the Uniform Code of Military Justice, to wit: sexually assault [REDACTED] by penetrating her vulva with his penis, by using unlawful force, and in order to effect the object of the conspiracy the said SENIOR AIRMAN LOGAN A. MCLEOD did provide funding for a lodging rental.

Specification 2: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, between on or about 1 August 2021 and on or about 5 August 2021, attempt to conspire with [REDACTED] to commit an offense under the Uniform Code of Military Justice, to wit: confine and hold, [REDACTED] a person not a minor, against her will, and in order to effect the object of the conspiracy the said SENIOR AIRMAN LOGAN A. MCLEOD did provide funding for a lodging rental.

Specification 3: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to unlawfully assault "Caitlin," a person whom he believed to be a child under the age of 16, by strangling her, to wit: choking her with a chain.

Specification 4: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to unlawfully assault "Caitlin," a person whom he believed to be a child under the age of 16, by suffocating her, to wit: taping her nose and mouth shut.

MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to unlawfully assault "Caitlin," a person whom he believed to be a child under the age of 16, by suffocating her, to wit: putting nose clips over her nostrils.

Specification 10: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to unlawfully assault "Caitlin," a person whom he believed to be a child under the age of 16, by tying "Sarah's" dead body to her.
