CHARGE I: Violation of the UCMJ, Article 80

Specification 2: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to wrongfully possess Ecstasy, a schedule I controlled substance, with the intent to distribute said controlled substance.

Specification 4: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to commit a sexual act upon a person whom he believed to be "Sarah," to wit: penetrating "Sarah's" vulva with his penis, by using unlawful force.

Specification 5: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, with premeditation, attempt to murder a person whom he believed to be "Sarah," by means of suffocating her.

Specification 8: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to wrongfully confine and hold "Sarah," a person not a minor, against her will.

Specification 9: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to wrongfully confine and hold, "Caitlin," a person he believed to be a minor whose parent or legal guardian the accused was not, against her will.

Specification 10: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to commit a sexual act upon "Caitlin," a person whom he believed to be a child who had attained the age of 12 years but had not attained the age of 16 years, to wit: penetrating her vulva with his penis, by using unlawful force.

Specification 11: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to knowingly and wrongfully distribute child pornography, to wit: a recorded video of "Caitlin," a person whom he believed to be a minor under the age of 18, engaging in sexually explicit conduct, and that said conduct was of a nature to bring discredit upon the armed forces.

Specification 12: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, on or about 18 September 2021, attempt to knowingly and wrongfully produce child pornography, to wit: recording a video of "Caitlin," a person whom he believed to be a minor under the age of 18, engaging in sexually explicit conduct, and that said conduct was of a nature to bring discredit upon the armed forces.

CHARGE II: Violation of the UCMJ, Article 131b

Specification: In that SENIOR AIRMAN LOGAN A. MCLEOD, United States Air Force, Air Force Life Cycle Management Center, Detachment 5, Maxwell-Gunter Annex, Alabama, did, at or near Montgomery, Alabama, between on or about 3 August 2021 and on or about 11 September 2021, wrongfully do a certain act, to wit: directed [REDACTED] to delete text messages regarding his criminal conduct in order to obstruct the due administration of justice in the case of United States v. Mcleod, against whom the accused had reason to believe there would be criminal proceedings pending.
