BAKER, United States Space Force, Delta 4 Detachment 2, Buckley Space Force Base, Colorado, did at or near the State of Colorado, while en route to Peterson Space Force Base, Colorado, on or about 14 October 2022, with intent to deceive, make to [REDACTED], an official statement, to wit: "my wife [REDACTED] is driving me to the virtual treatment team meeting," or words to that effect, which statement was totally false, and was then known by the said FIRST LIEUTENANT TRAVIS C. BAKER to be so false.

Specification 2: In that FIRST LIEUTENANT TRAVIS C. BAKER, United States Space Force, Delta 4 Detachment 2, Buckley Space Force Base, Colorado, did at or near the State of Colorado, while en route to Buckley Space Force Base, Colorado, on or about 18 October 2022, with intent to deceive, make to [REDACTED], an official statement, to wit: "I will have my Lyft drop me off at Safeway," or words to that effect, which statement was totally false, and was then known by the said FIRST LIEUTENANT TRAVIS C. BAKER to be so false.

Specification 1: In that FIRST LIEUTENANT TRAVIS C. BAKER, United States Space Force, Delta 4 Detachment 2, Buckley Space Force Base, Colorado, did at or near Peterson Space Force Base, Colorado, on or about 14 October 2022, near the West Gate, physically control a vehicle, to wit: a pickup truck, while the alcohol concentration in his blood equaled or exceeded 0.08 grams of alcohol per 100 milliliters of blood, which is the limit under Colorado Revised Statute Section 42-4-1301, as shown by chemical analysis, and while drunk.

Specification 2: In that FIRST LIEUTENANT TRAVIS C. BAKER, United States Space Force, Delta 4 Detachment 2, Buckley Space Force Base, Colorado, did at or near Buckley Space Force Base, Colorado, on or about 18 October 2022, near the 6th Street Gate, physically control a vehicle, to wit: a pickup truck, while the alcohol concentration in his blood equaled or exceeded 0.08 grams of alcohol per 100 milliliters of blood, which is the limit under Colorado Revised Statute Section 42-4-1301, as shown by chemical analysis, and while drunk.

CHARGE III: Violation of the UCMJ, Article 133

Specification 1: In that FIRST LIEUTENANT TRAVIS C. BAKER, United States Space Force, Delta 4 Detachment 2, Buckley Space Force Base, Colorado, was, at or near Peterson Space Force Base, Colorado, on or about 14 October 2022, dishonorably and disgracefully disrespectful to [REDACTED] and which conduct, under the circumstances, was unbecoming an officer and a gentleman.

Specification 2: : In that FIRST LIEUTENANT TRAVIS C. BAKER, United States Space Force, Delta 4 Detachment 2, Buckley Space Force Base, Colorado, was, at or near Aurora, Colorado, on or about 18 October 2022, in a public place, to wit: the parking lot of a 7-Eleven, drunk and disorderly while in uniform, to the disgrace of the armed forces, and which conduct, under the circumstances, was unbecoming an officer and a gentleman.
