What is worse, you choose to drive under the influence of alcohol twice in the span of just four days. Your blood alcohol concentration was 0.282% at Peterson Space Force Base, Colorado Springs, Colorado and 0.217% at Buckley Space Force Base, Aurora, Colorado. That is more than two and half times the legal limit in both cases. Not only did you put yourself in danger, you put ever single driver and passenger in your path from Buckley Space Force Base to Peterson Space Force Base in danger. Finally, after being stopped by Peterson Space Force Base law enforcement under the suspicion of drunk driving, you continued your dishonorable behavior by disrespectfully speaking to the responding officer in a manner unbecoming an officer and a gentlemen. You have disgraced the Department of the Air Force, your unit, and yourself.


