- 1. Pursuant to Military Rule of Evidence ("M.R.E.") 304(d), the Government provides notice of the following oral or written statements made by Captain Tony A.T.S. The Government specifically gives notice of the following statements of the Accused from Exhibits 2 through 6 of the ROI, pages 13 through 68, incorporating Exhibits 28 through 33, pages 130 through 174, in the Defense Travel System ("DTS") vouchers reflecting amounts paid out to the Accused and the Accused's signed travel vouchers. The Government specifically gives further notice of the following as "statements" of the Accused from her digitally signing the medical travel vouchers in DTS, concurring (in whole or in part) with the statement, "I certify that this voucher is true and correct to the best of my knowledge and belief, and that payment or credit has not been received by me. The submitted DTS vouchers (and associated electronic signatures, or "statements") are for appointments that occurred on the following dates:

- "Q: Between JAN 2022 and AUG 2022, did you knowingly and wrongly, file numerous fraudulent DTS vouchers, along with fraudulent documents, allegedly validating appointments in which you admitted you never attended, then requested reimbursements reflecting fraudulent travel mileage and fraudulent

lodging, for medical appointments which you never attended?" "A: Yes."

- v) The Accused initialed next to and after both the "Q" and the "A" of the following typed statement:
- "Q: Between JAN 2022 and AUG 2022, did you knowingly and wrongly utilize your government travel card, making numerous unauthorized transactions for personal use?"

"A: Yes sir."

- vi) The Accused initialed next to and after both the "Q" and the "A" of the following typed statement:
- "Q: Between JAN 2022 and AUG 2022, were you absent from your duty location on at least 40 days, because you deceived your leadership, falsely claiming you had medical appointments?"

"A: Yes sir."


- vii) The Accused initialed next to and after both the "Q" and the "A" of the following typed statement:
- "Q: Did you knowingly and wrongly between JAN 2022 and AUG 2022 file fraudulent documents along with fraudulent DTS vouchers, for the sole purpose of not having to report for duty and to fraudulently receive monies for expenses you fraudulently stated were part of the fraudulent travel?"

 "A: Yes sir."
- viii) The Accused initialed next to and after both the "Q" and the "A" of the following typed statement:
- "Q: Do you have anything to add to this statement?"
- "A: No sir. ///END OF STATEMENT///"
- ix) The Accused initialed next to and after the following typed statement: "I hereby voluntarily and of my own free will make this statement without having been subjected to any coercion, unlawful influence, or unlawful inducement. I swear (or affirm) I have read this statement, initialed all pages and corrections, and it is true and correct to the best of my knowledge."
 - x) The Accused signed the first page of the AF Form 1168.
 - xi) The Accused signed the second page of the AF Form 1168.
